The April 10th Law Tribune featured an article on Joe Geremia, who will be honored by the Judicial Branch for his Low Bono practice. "'By dedicating a significant part of his practice to advocacy as an attorney in the Waterbury Juvenile Court, attorney Geremia has committed himself to helping the most needy and least advantaged population that comes through the courthouse doors,' said Beth Duffy Burns, deputy chief clerk for juvenile matters in the Waterbury Judicial District. Geremia represents abused and neglected children. He also represents parents accused of abuse and neglect who are in jeopardy of losing their children, a task made difficult because issues related to
